	Superintendent's Report – Academic Services Update – Elementary – Mr. Murray gave an elementary update. Professional Development took place last week which focused on high-leverage strategies. The ELA & Math Coach helped teachers to better understand the new coaching model and work took place on

consolidating multi-tier systems of support processes. Teachers had time to collaborate and work on best practice strategies for math. The 1st trimester is ending soon and new elementary report cards are coming home on the 19th. The math curriculum preview is on Nov. 20th (3 vendors) and staff will decide which materials we may want to pilot. Parent teacher conferences are taking place on Nov. 20 & 21.

Secondary – Ms. McFarlane gave a secondary update. The middle school had AVERT safety training on the morning of the PD Day & in the afternoon, Capturing Kids Hearts and transformation work on the Academies of the Middle School took place. A curriculum presentation from 3 companies took place for math review last week. There were two products that were selected and teachers will be looking further at those. The high school Advisory Board Meeting took place last week and there was a great turn-out. Productive conversations took place and the culinary students & Chefs did a great job in providing a Mediterranean dinner. A non-profit exploration fair will be taking place at the middle school on February 6th.

Ms. Banach asked if the fair is for everyone or just certain grade levels and Ms. McFarlane responded that all 3 grade levels are participating this year. Moving forward it will just be a 6th grade experience.

Ms. Eichhorst asked if board members could attend & Ms. McFarlane stated that they absolutely were welcome to attend.
